**Decision:** Fine of 3.000 € (suspended fine for the rest of the season)  
**Reason:** In the hearing the driver stated that some of the written words in the press are not said by him. He agreed that some comments he really said have not been respectful towards the Stewards and also towards the FIA. He promised to try to doesn't do so in the future because he has the full respect for the work of the Stewards and the FIA.
